**Producers are presumed to be related**, in the absence of proof to the contrary, if they are not operating at arm's length. That happens to a producer in any of the following circumstances:

- One of the producers is the spouse or common-law partner of the other producer (the total amount is limited for the **couple**, regardless of the percentage of participation of either in a corporation/partnership/cooperative).
- One of the producers is entitled to 25% or more of the profits or revenues of the other producer.
- One of the producers owns at least 25% of the voting shares of the other producer.
- One of the producers owns at least 25% of the voting shares of the other producer or of a corporation/partnership that directly or through any other corporation/partnership owns 25% of the voting shares of the other producer.
- The producer control or is controlled, directly or indirectly in any manner, by the same person or group of persons as the other producer.
- The producer carries on a farming operation **in partnership** with the other producer.
- The producer shares any management services and administrative services, equipment, facilities or overhead expenses of a farming operation with the other producer, but is not in partnership with that the other producer.
